My participation could also lead to loss or damage to my personal property. I expressly agree to assume all risk of injury and death and loss of personal property which may result from my participation in these Fishing Tournaments. In exchange for being permitted to participate in the tournament, I hereby **RELEASE AND DISCHARGE** the tournament's organizer and the tournament sponsor's, their officers, directors, agents, employees and legal representatives (the "Released Parties") from any and all liability for any injury, damage or other loss sustained by me which may arise from my participation in the above tournament, including, but not limited to, any claim I or my heirs may have for loss, personal injury or casualty of any kind, injuries, damages or other loss sustained by me, caused by the negligence or strict liability of the Released Parties. I do not release the Released Parties from liability for willful or intentional misconduct. I expressly recognize that loss of property, injury, or death could arise from (1) the fishing and boating activities contemplated by the tournament. (2) the fact that competition rules contemplate that some participants will fish in boats belonging to OTHER participants in the contest. (3) the fact that the risk normally encountered in open water fishing from a boat may be enhanced by the exposure to the elements and other risks inherent in the outdoors competition. I warrant that I am in good physical and mental health and am physically capable of withstanding the rigors and requirements of professional level fishing competition.
